Must be self-funding, no outside money

Must be profitable to support University

University is getting less and less money from the state

The changes we are seeing is a result of the food survey results

Auxiliary is self-supporting

2774 students less than in '09

Creates a gap in income v money spent

'Aramark is not a monopoly'

We use them because we do not have the resources/reserves to operate dining ourselves

Aramark invests money to bring businesses to campus (steak n shake and chick fil a)

It is a true partnership with AM

Why do they have dining dollars and Phoenicia does not
They were offered the same deal, Phoenicia chose to go a different route

They give 10% of profit to Aramark

They don't have those numbers
They want that space to grow catering to increase revenue to the University
