Dawn has served as Miss Deaf Ohio, president of the Lima District Society of the Deaf, chairperson of Northwest Four County Deaf and Hearing Friends, chairperson of the Ohio Rehabilitation Services Commission Advisory Committee on Deafness, board member of the Toledo Hearing and Speech Center, and member of the Hearing Impaired Services of Northwest Ohio Advisory Committee on Deafness. She has also been a member of the Ohio Association of the Deaf, Ohio Deafness and Rehabilitation Association, and Good Shepherd of the Deaf Lutheran Church.

She is employed as Vocational Counselor at the Bureau of Vocational Rehabilitation, One Government Center. Her duties include working with hearing impaired and deaf clients to obtain their vocational goal by coordinating evaluation, assessment of their skills, drawing up individualized written rehabilitation programs to provide physical and/or mental restoration, training, job seeking skills and/or job leads.

Grace is a member of the Ohio Association for the Deaf and currently active as a member of the Deaf Advisory Committee for the Toledo Society for the Handicapped's Communication Action Network. She represented Ohio at the regional Deaf Leadership Conference and went on to represent the region at the national conference in Washington D.C.
