WE MUST BE EQUALLY UNITED TO WIN THE PEACE. The United Nations must aim for total victory—in war and in peace.

ONCE MILITARY VICTORY is achieved, enormous tasks will still lie ahead: Feeding, clothing and housing people in devastated areas—preventing the spread of epidemics—reorganizing political and economic life and restoring order.

WHAT PART WILL AMERICA PLAY in meeting these problems?

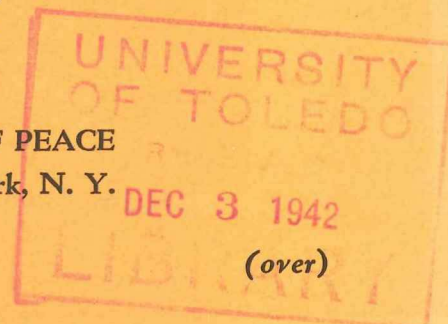
TODAY, WE ARE FIGHTING to preserve our way of life, our freedom, our Bill of Rights. We now know that we cannot retain our freedom, our democratic rights, if people in other parts of the world are deprived of theirs. We know now that our oceans, our military and industrial strength do not automatically protect us from attack. Our security is part of world security.

HOW CAN WE bring about and maintain the security we want—security for the United States—security for the United Nations—security for all nations—once the Axis forces are defeated? The winning of the peace will need the same all-out united effort as winning the war.

THIS TASK IS PART OF TODAY'S CHALLENGE. It is a challenge for the United States. We must not walk out on the peace at the close of this war.

HOW YOU CAN HELP

1. INFORM YOURSELF

The Commission to Study the Organization of Peace, since the fall of 1939, has been at work studying the problems of organizing peace on a just and durable basis and it has issued two reports and popular educational material. Read the Commission's official reports, one dealing with broad general principles and the second discussing the specific jobs to be done in the transitional period immediately after the war. Pass them on to your friends and business associates.

2. FORM A STUDY GROUP

Organize a group in your community to study what we are fighting for. Such a group can be started among your friends, or in your church, club, college or union. We can help you with study outlines, pamphlets, bibliographies, etc.

3. ORGANIZE MEETINGS

Encourage public discussions—mass meetings or small informal talks. Discuss the necessity of making permanent the victory in the war by organizing the peace.

4. USE THE NEWSPAPERS AND RADIO

Seek the cooperation of your local newspapers and radio. Letters to editors, editorials, and radio programs should help to crystallize the post-war aims of the American people.
