The undersigned, all of whom are citizens of the United States, desiring to form a corporation not for profit under the General Corporation Act of Ohio, do hereby certify:

FIRST

The name of this corporation is L'ALLIANCE FRANCAISE de TOLEDO, OHIO, INC.

SECOND

The place in this state where the principal office of this corporation is to be located is in the City of Toledo, Lucas County, Ohio.

THIRD

The purposes for which this corporation is formed are without profit to advance the education and general welfare of the citizens of Toledo and vicinity through study of the culture of France and, in furtherance thereof, to engage speakers, present courses of instruction, lecturers, literary papers, films, concerts, plays, and other cultural programs; to sponsor and award scholarships, awards and prizes, and otherwise to recognize, encourage and contribute to excellence in study of the culture of France; to raise by membership dues, gifts, donations, bequests, subscriptions or admissions, funds to carry out the foregoing; and generally to do any and all things permitted by law to a corporation not for profit.

FOURTH

No part of the activities of this corporation shall be devoted to carrying on propaganda or otherwise attempting to influence legislation, or to participate in

or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office, and no part of the funds, income or net earnings of this corporation shall be used or devoted to any other purposes than those set forth in Article Third or to the benefit of any private member or individual.
